**SUPERINTENDENT'S REPORT:**

The Superintendent reported on parent feedback given at the Parent-Teacher Advisory Committee Meeting. He liked the feedback from parents in the small group. Approving

the meeting notes was questioned by Michael Davenport. Answer: it was a committee meeting.

Revisions to the discipline code were discussed. Superintendent reviewed updates to the student handbook which include a provision, called for by SB100, which requires the elimination of zero tolerance in the language code. This change provides a wider option for Deans to use in discipline issues.

The next item concerned a late start change for 2017-2018 school year. Over 2000 responses to the school's survey were received, 58% from students and 42% from parents. Eighty percent of the respondents saw the benefit of the change to be a more consistent schedule. Transportation concerns came up through the surveys. Consistency needs were stressed. Meeting and looking at student performance on a weekly basis and responding immediately is the effective way to meet student needs. The superintendent recommended they move forward with every Monday being a late start. This would begin after Labor Day. Moving the late starts to Monday would increase the number of days that they currently do this year. An official vote was not taken, but all members said they were in favor of the change.

The 2017-18 recommended calendar was presented. This year they formed a very large committee across the district and after each meeting the updated draft calendar went out to the staff. Transparency in building the calendar was important. The first draft was asked to be approved but not voted on. Currently, the proposed calendar has 85 days in first semester and 90 days in second semester. The superintendent said that there is state mandated testing in second semester, so these dates work out. Don Renner was in the minority, stating he'd prefer to start after Labor Day. The main push for the calendar change was to have finals before Christmas break.

## **CONSENT AGENDA**

## RECOMMENDED FOR ACTION

Mark Staehlin reviewed a resolution providing for the issue of approximately \$2,000,000 in bonds for fire prevention and safety, energy conservation, and school security purposes. He stated that BMO bank, like a lot of other banks, did not bid because of the state of financial affairs in Illinois. JPMorgan gave the best bid/very competitive, at \$2,309,000. All cost of issuance is in this one time cost, no extras added on. The board was asked to approve the issuance of the bonds and the bid from JP Morgan. The motion to approve was made by Rick Pavinato, and Terry Pavesich seconded. The motion carried.
