- a. Mike Baker, Assistant Village Manager reported
- b. Video shared related to history of downtown planning
- c. Two financial tools essential to downtown planning, Tax Increment Financing (TIF) district & Special Service Area (SSA) both expire 12/2020.
- d. Nearly all revenue generated from TIF is used to make debt service payments which will be paid off in 2021. The revenue source expires the same time as the debt is paid off.
- e. The Downtown Management Corporation is a key partner for business attraction & retention.
- f. Complete recommendations for downtown improvement is included in the 2017 comprehensive plan.
- g. After the expiration of the TIF & SSA, there will still be ongoing & additional expenses without resources to support them, requiring the Village to examine resources to determine the funding source to bridge the gap.
- h. Importance of accessibility & parking are key components of plan.
- i. Importance of functions performed by DMC, especially attraction & retention of businesses.
